Doctors of BC Benchmark Member Survey Contest

Contest Terms and Conditions - May 2025

Contest Period

1. This contest (the "**Contest**") runs from 8:00am PT on April 16, 2025 to 11:59 pm PT on May 7, 2025, in British Columbia (the "**Contest Period**") and will be subject to the below contest conditions (the "**Contest Conditions**").

Qualified Entrant

- 2. A qualified entrant (the "**Qualified Entrant**") means an individual who is a Canadian resident (excluding residents of the Province of Quebec) throughout the Contest Period, is 19 years of age or older, and who is:
 - a) a Doctor of BC member in good standing; and
 - b) not an employee or board member of Doctors of BC.

How to Enter

There are two (2) ways to enter the Contest during the Contest Period:

3. a. To enter the Contest, a Qualified Entrant will complete the Benchmark Member Survey via the URL provided in the original emailed invitation.

b. A Qualified Entrant may also enter the Contest by emailing: (i) their full name, (ii) Doctors of BC membership number, and (iii) the year they became a member of Doctors of BC to communications@doctorsofbc.ca. The subject line of the email should state "Benchmark Member Contest". An entry will be disqualified if it is missing any of the above details.

- 4. An entry must be received by Doctors of BC's external polling service provider, TWI Surveys (the "**Service Provider**") before the end of the Contest Period to be eligible to win the Prize.
- 5. There is a limit of one (1) entry per individual during the Contest Period.
- 6. No purchase is necessary to enter into this content.

<u>Prize</u>

- 7. There is a total of two (2) prizes (each a "Prize") available to be won in this Contest:
 - Two (2) Apple iPads valued at \$ 559.38 each.
- 8. The odds of winning a Prize depends on the number of eligible entries received.

- 9. A Prize must be accepted as awarded and cannot be exchanged for cash. A Winner who does not accept the Prize as awarded, at Doctors of BC's sole discretion, will be deemed to have refused the Prize. Doctors of BC reserves the right to disqualify Winners who do not accept the Prize as awarded and select another Qualified Entrant as the Winner.
- 10. In order to receive a Prize, the Winner must satisfy Doctors of BC that the Winner is entitled to receive the Prize in this contest, correctly answer a time-limited skilltesting question, and agree to such representations, releases, waivers and indemnities as Doctors of BC may require. Doctors of BC has no obligation to deliver a Prize to a Winner who cannot satisfy these requirements.

Draw

- 11. A draw to select one Qualified Entrant (the "Drawn Entrant") will be conducted one (1) day after the Contest Period ends or as soon as practicable thereafter by the Service Provider in Vancouver, Canada. The Drawn Entrant is deemed to be a winner (the "Winner") when Doctors of BC along with its Service Provider confirms the Drawn Entrant meets these Contest Conditions.
- 12. Doctors of BC will make reasonable efforts to contact the Drawn Entrant using the contact information provided. If a Drawn Entrant does not accept the Prize within seven (7) days after Doctors of BC first attempts to contact the Drawn Entrant, that Drawn Entrant will be disqualified and another Drawn Entrant selected until a Drawn Entrant is contacted, accepts the Prize and is deemed a Winner in accordance with these Contest Conditions. Each subsequent Drawn Entrant will have seven (7) days to accept the Prize after Doctors of BC first contacts the Drawn Entrant.
